Washing and shredding of hazardous waste (packaging) in plastic and metal (Via Malpasso 63/65 Castelfranco di Sotto PI). Stocking of special dangerous and non-dangerous waste, inertization of non-dangerous waste, stocking of waste by-products of animal original, category 3 (at the premises of Via Usciana 115/A Castelfranco di Sotto - PI). Collection and transport of special hazardous waste (also under ADR regulations) and non-hazardous waste, for disposal and/or recycling/reuse. Executing laboratory chemical analyses in environmental and leather sectors. Intermediation of dangerous and non-dangerous waste without detention. (Via Lancioni 2 Santa Croce sull'Arno). Stocking, shredding and mixing of hazardous waste. Inertization of hazardous and non-hazardous waste. Soil washing (washing of polluted soil). Treating of dangerous and non-dangerous liquid waste (chemical-physical and biological). Executing laboratory chemical analyses in environmental and leather sectors on own behalf. (Via Ragghianti 12 Pisa - PI).
